The following forms an integral part of this Stallion Service Agreement and must be completed in full before the Agreement is accepted by Greystone Aristocrat Limited ("the Stud"). They record key details, including commercial terms, mare identification, veterinary authority, and contact information. By signing, the Mare Owner confirms that all information provided is accurate and complete. Any omission or incorrect information may affect the Live Foal Guarantee and other terms of this Agreement. This Agreement is between the Stud and the Mare Owner, being the person responsible for the mare, whether owned or leased.

FEES

A non-refundable Booking Fee of NZD 500 + GST is payable upon signing this Agreement. This secures the Mare's place in Greystone Aristocrat's breeding book for the current season. The Booking Fee will be credited against the Service Fee of NZD 1,800 + GST, leaving a balance of NZD 1,300 + GST. The balance must be paid in full before the first shipment of semen is dispatched.

The first semen collection is included in the Service Fee. Each additional collection will incur a Collection Fee of NZD 350 +GST, which covers collection, preparation, and packaging.

All transport and courier costs for semen shipments will be invoiced to the Mare Owner.

RESERVATIONS

Payment of the Service Fee confirms the Mare's reservation to be bred to Greystone Aristocrat during the breeding season, which runs from 1 September 2025 to 1 April 2026. To ensure timely delivery, the Mare Owner (or their veterinarian) must provide early notice of semen requirements. Delays in communication may result in missed breeding opportunities.

GREYSTONE ARISTOCRAT — STALLION SERVICE AGREEMENT (NEW ZEALAND) — 2025/26

This Stallion Service Agreement ("Agreement") is made between the stallion owner or authorised agent trading as the Stud ("Stud") and the registered owner or duly authorised lessee of the mare as named in "Mare Owner" in this Agreement. Its purpose is to set out the terms under which the stallion Greystone Aristocrat ("Stallion") will be used to breed the mare identified in this Agreement during the 2025/26 New Zealand breeding season.

Upon receipt of the Booking Fee and a signed copy of this Agreement, the Stud will reserve a place for the Mare in the Stallion's book for the 2025/26 season. The New Zealand sporthorse breeding season for shipped semen runs from 1 September to 1 April each year, with any collections outside these dates by prior arrangement only. The service method is artificial insemination using fresh, chilled and frozen semen ("AI") only.

The Mare Owner agrees to pay: (a) a non-refundable Booking Fee (credited against the Service Fee) upon signing; (b) the remaining Service Fee in full prior to the first shipment of semen; (c) any Collection Fees for additional semen collections beyond the first, and all Transport/Freight costs for semen shipments; and (d) all agistment, farrier, veterinary and sundry charges if the Mare is resident on farm. These amounts are exclusive of GST unless stated otherwise, and all invoices are payable within the timeframes specified on the invoice.

The Mare Owner (or their veterinarian/semen base) must give the Stud reasonable notice of the Mare's cycle and place orders at least 48 hours before semen is required. The Mare Owner assumes the risk of delay or damage in transit beyond the Stud's reasonable control.

The Stud may refuse service to any mare at its sole discretion if, in the Stud's reasonable opinion or its veterinarian's opinion, the mare is not in sound breeding condition or poses a biosecurity risk. Where the Mare is presented on farm, she must be halter-broken, have shoes removed, be in good health, and be managed for internal parasites according to Stud instructions. The Stud may require vaccination (including Strangles and Salmonella) unless current vaccination proof is provided on arrival, and may engage routine or emergency veterinary treatment in the Mare's best interests with costs to the Mare Owner.

While the Mare and any foal at foot are on farm, the Stud will take all reasonable care customary for a professional equine breeding facility. All animals remain at the Mare Owner's risk, and the Mare Owner is encouraged to maintain appropriate mortality and major medical insurance.

The Stud provides a Live Foal Guarantee on the following basis. A "live foal" is a foal that stands and suckles unassisted and survives for at least 48 hours after birth. If no live foal results, the Mare will be entitled to one Return Service in the following breeding season on the same terms, provided that (i) the Service Fee and all related charges were paid within trading terms; (ii) the Mare received appropriate care throughout gestation; (iii) the foaling was supervised by competent personnel with veterinary support available; and (iv) the Mare Owner supplies a veterinary certificate within the timeframe specified by the Stud (typically within 10 days of the foal's death) confirming the circumstances. Return Service covers the service only; all collection, transport, veterinary and agistment costs for the return are the Mare Owner's responsibility.

Return Service and/or LFG will not apply where the Mare is sold, exported, or dies before foaling unless the Stud consents to substitution; where the Mare Owner fails to foal the Mare under appropriate supervision with on-call veterinary attendance; where negligence in management contributed to loss; or where accounts remain unpaid within trading terms.

If the Mare fails to conceive or becomes unsuitable for breeding, the Mare Owner may nominate a substitute mare acceptable to the Stud; approval is at the Stud's discretion and may be conditioned on updated veterinary information.

If, before the Mare's first shipment or service, the Stallion dies, is sold, or becomes unfit for breeding, the Stud will refund the Service Fee or offer a suitable alternative, at the Mare Owner's election. If the event occurs after the first shipment or service, the Agreement may be terminated without further liability other than charges already incurred.

The Stud will issue one breeding certificate per contract once the Mare is confirmed 42 days in foal and all outstanding invoices have been paid. The Mare Owner acknowledges the Stud may submit service return data to the registry or breed society (IDHSNZ) for eligibility purposes.

Embryo transfer, embryo freezing or the retention of unused semen doses is prohibited unless expressly pre-approved in writing by the Stud. Any frozen semen supplied remains the Stud's property until insemination; unused straws must be returned or disposed of per the Stud's instructions.

To secure all amounts owing, the Mare Owner grants the Stud a purchase-money security interest under the Personal Property

Securities Act 1999 over the Mare while in foal, any resulting foal, and their proceeds, and agrees to provide all information necessary for registration; the Mare Owner waives the right to receive a verification statement. In addition, the Stud shall have a lien over the Mare and/or progeny for unpaid amounts and may, after reasonable notice, sell the Mare and/or progeny to recover outstanding sums if charges remain unpaid.

This Agreement is personal to the parties and may not be assigned by the Mare Owner without the Stud's written consent. If the Mare is sold or consigned for sale before foaling, all sums due under this Agreement become immediately payable and the Mare Owner must notify the Stud and ensure that any purchaser agrees in writing to be bound or that all amounts are settled beforehand.

Except as expressly stated herein, the Stud makes no representation as to the Stallion's fertility or the certainty of conception. The Mare Owner releases the Stud from responsibility for disease, injury or accident to the Mare or foal except to the extent caused by the Stud's gross negligence or wilful misconduct.

Operational instructions must be provided promptly by the Mare Owner or their veterinarian. Formal notices under this Agreement must be sent to the addresses as recorded in "Mare Owner" and are deemed received when delivered in person, on the third Business Day after posting within New Zealand, or on the day of confirmed email transmission.

The Stud is not liable for any act, omission, or failure under this Agreement, including damaged, lost, or delayed semen, where such act, omission, or failure arises directly from a cause beyond the Stud's reasonable control. The Stud will notify the mare owner as soon as practicable after becoming aware of such an event.

This Agreement is governed by the laws of New Zealand. The parties will first seek to resolve any dispute in good faith at a managerial level. If unresolved within 14 days, the parties may refer the dispute to mediation in New Zealand before commencing court proceedings.

This Agreement constitutes the entire agreement concerning the Stallion's service to the Mare for the stated season and supersedes all prior discussions. Any variation must be in writing and signed by both parties. If any provision is invalid or unenforceable, it will be read down or severed to the extent necessary without affecting the remaining provisions.
